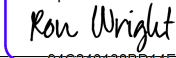

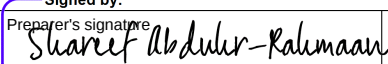

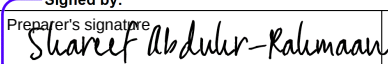

OBJECTIVE: Our financial assistance program aims to prevent eviction and homelessness. We achieve this through emergency financial assistance payments toward rent, utilities, or move-in costs for those transitioning to permanent housing. For all clients, any type of financial assistance (move in, rent or utilities) are considered equivalent to permanent housing stability.

ELIGIBILITY: Eligible clients must reside in one of the following zip codes: 98109, 98119, 98199 Anyone who is homeless/housing/receives a section 8 voucher is income-qualified. Anyone whose income is solely derived from Social Security public benefit (TANF, ABD, etc.) is income-qualified. Anyone who has received a pay-or-vacate/eviction notice or shut-off notice is eligible. For those who have NOT received an eviction/shutoff notice, nor meet the income eligibility is based on self-identified client needs. In order to receive assistance, client must provide proof of income.

AMOUNT PROVIDED: The dollar amount of financial assistance provided is based on an assessment of the client's financial situation, as well as the current status of Queen Anne Helpline's client assistance budget. Our rental assistance is based on the fair market value of one month's rent per instance of assistance (unless the amount owed on an eviction notice is greater than the fair market value, in which case we provide assistance up to a maximum of \$800 annually. For utility shut-off notices, our assistance covers half the amount owed, up to a maximum of \$400 annually, required to prevent a shut-off.

Clients are eligible for up to two instances of financial assistance within a 12-month period, based on the amount of assistance received. Individuals or families can receive a one-time payment of \$800 and regain eligibility for assistance, or they can receive a maximum of 2 instances of support over a 12-month period. If the amount owed by a client exceeds the amount we can provide, we may refer to partner agencies (including Ballard Food Bank, St. Vincent DePaul, etc.).
