HOMELESSNESS PREVENTION: OUR EMERGENCY FINANCIAL ASSISTANCE HELPED 643 INDIVIDUALS REMAIN STABLY HOUSED BY PREVENTING EVICTIONS AND UTILITY SHUT-OFFS AS WELL AS FACILITATING MOVES INTO MORE SECURE HOUSING. THESE ARE 643 NEIGHBORS WHO WERE ABLE TO REMAIN RESILIENT THROUGH DIFFICULT TIMES, PREVENTING THE RISK OF EXPERIENCING HOMELESSNESS. OF THE NEIGHBORS WE SERVED, 60% EXPERIENCED ONE OR MORE DISABILITIES, 31% WERE SENIORS, 12% WERE FAMILIES AND 12% WERE VETERANS. AMONG APPLICANTS WHO RECEIVED EMERGENCY FINANCIAL ASSISTANCE IN 2020, 58% WERE IN SUBSIDIZED OR TRANSITIONAL HOUSING AND 57% WERE WOMEN. ALL OF OUR NEIGHBORS WHO RECEIVED FINANCIAL ASSISTANCE WERE GIVEN FINANCIAL COACHING AND CONNECTED TO RESOURCES THAT WOULD SUPPORT THEIR ONGOING FINANCIAL WELL-BEING.

SUPPORT SERVICES: BEYOND INTERVENING TO SUPPORT HOUSING STABILITY, QUEEN ANNE HELPLINE BUILDS STRONGER COMMUNITY IN A VARIETY OF WAYS WITHOUT ANY RESTRICTION BY ZIP CODE OR HOUSING STATUS. THROUGH THIS BROADER APPROACH, WE REACHED 2,439 INDIVIDUALS IN 2020. WE MAINTAINED AND DEEPENED OUR IMPACT IN SPITE OF DISCONTINUING IN-PERSON APPOINTMENTS IN THE SPRING DUE TO THE COVID-19 PANDEMIC. LEVERAGING VOLUNTEER DELIVERY DRIVERS AND GENEROUS IN-KIND DONORS, WE PROVIDED OVER 5,300 PIECES OF CLOTHING, LINENS AND HYGIENE PRODUCTS, AND 4500 MEALS. AS THE PANDEMIC DRAGGED ON, MANY NEIGHBORS SOUGHT OUR SERVICES FOR THE FIRST TIME, AND QUEEN ANNE HELPLINE DEMONSTRATED ITS VALUE AS A COMPASSIONATE COMMUNITY HUB AND STEADFAST LOCAL RESOURCE.
